## IAP PICC Election 2021 Notification

1. Nominations are invited from the members of IAP PICC for IAP PICC Executive Body Election 2021 which is being conducted in 2020. Only eligible Life members of the Society, who have paid their annual subscription & cleared all dues of CIAP for the current year as of 31 March 2020 and also life member of IAP PICC Chapter, shall be eligible to offer themselves as Candidates for election or to Propose or Second the candidature of any member or to participate as a Voter in the elections. The proof of eligibility rests with the candidates. The Election for the post of Chairperson elect, Vice Chairperson and Executive Committee members for 2021 will be held by-voting only.
2. Nominations are invited for the post of Vice Chancellor for the College Council of Pediatric Intensive Care Chapter – one post and Executive Board Members – 4 posts. These will be elected by the teachers of the College Council and not by the life members of IAP PICC
3. The election schedule is printed in the nomination form. In special circumstances Returning Officer can change any of the dates of the schedule.
4. Candidates being nominated or want to nominate themselves must fill in the Prescribed Nomination Form completely. Incomplete or Inaccurate Nominations will not be valid. The Proposers and Seconders of the Candidates must be valid Members, whose names appear in the PICC member list as of 30<sup>th</sup> September 2020 and who have paid their annual subscription & cleared all dues of PICC for the current year as of 30<sup>th</sup> September 2020. Their names and addresses must match with that of the Central IAP list.
5. Candidates, Proposers & Seconders of the Nominations filed should submit their details in the prescribed form sent to all IAP PICC members/downloadable from IAP PICC website ([www.iapidc.org](http://www.iapidc.org)).
6. **Proposer and seconder should be the life member of the PIC Chapter. Proposer and seconder can send in their consent via email also and the copy of the email can be attached along with the application form.**
7. A member can be nominated for more than one post (e.g., Chairperson as well as for EB member), but will have to withdraw in writing from all other posts, except one post, before the last date of withdrawal, failing which, all nominations for all posts filed by that member will stand cancelled.
8. In the event of an error in a Nomination Form submitted, more than one Nomination Form may be filed for the same member for the same post. However, if multiple forms are sent for the same post, any one correct form will be accepted.
9. The nomination papers will be scrutinized by the IAP PICC Returning Officer or his/her appointed nominees for its validity. After scrutiny the Returning Officer shall send the list of valid Candidates to IAP PICC for posting on the IAP PICC website. Each eligible Candidate will also be intimated by email. Reasons for rejection can be requested by the Candidate only, by sending an Email to Chief Election Commissioner. Any Candidate whose nomination has been accepted can withdraw his nomination on or before the specified date of withdrawal. The decision of the Chief Election Commissioner will be final.
10. IAP PICC Chapter Members whose names appear on the PICC list as of 30<sup>th</sup> September 2020, are eligible to participate in the Election Process. Office will not be liable for Non receipt or delay in receipt of ballot papers.
11. **All Nominations papers of Candidates must be sent to the Chief Election Commissioner's Office only. Nominations sent elsewhere will be invalid.**
12. The correspondence from Members related to IAP PICC Election should have Full Name, address, IAP membership number, email ID & cell phone number.

**Eligibility criteria for the candidates of IAP PICC Executive Board:**

- (i) Candidate contesting for the post of Chairperson Elect should have served as an office bearer for any of the posts for at least one complete term and should have been member of the chapter for at least ten years.
- (ii) Candidate contesting for the post of Vice Chairperson should have served as an office bearer for any of the posts for at least one complete term and should have been member of the chapter for at least seven years.
- (iii) Candidate contesting for the post of Executive Board Member should have been a member of the IAP PICC Chapter for Five complete years.

**Eligibility criteria for the candidates of College Council Executive Board of IAP PICC:**

- (iv) The candidate contesting for the post of Vice Chancellor of the College Council of IAP PICC should be a teacher for at least seven years and should have been EB member of the Chapter for 2 years.
- (v) For the post of Executive board member of the College Council of IAP PICC, he / she should have been a teacher for at least five years.
- (vi) Term of Vice Chancellor is for two years Jan 2021 Dec 2022.
- (vii) Out of 8 positions of EB, 4 positions of College Council of IAP PICC are open to election from teacher pool to be filled every year so that 4 candidates elected for year 2021 may serve for Two years, i.e., Jan 2021 - Dec 2022.
