IAP PICC Election 2024 Notification

- 1. Nominations are invited from members of IAP PICC for the IAP PICC Executive Body- Election 2024 which is being conducted in 2023. Only eligible Life members of the Society, who have paid their annual subscription & cleared all dues of CIAP for the current year as of 31 March 2023 and life members of IAP PICC Chapter, shall be eligible to offer themselves as Candidates for election or to Propose or Second the candidature of any member or to participate as a Voter in the elections. The proof of eligibility rests with the candidates.
- 2. The election schedule is printed in the Election Notice. In special circumstances Returning Officer can change any of the dates of the schedule.
- 3. All nominated Candidates must fill in the Prescribed Nomination Form completely. Incomplete or Inaccurate Nominations will not be valid and there will be no corrections allowed after the last date.
- 4. The Proposers and Seconders of the Candidates must be valid Members, whose names appear in the PICC member list as of 31 st July 2023 and who have paid their annual subscription & cleared all dues of PICC for the current year as of 31 st July 2023. Their names and addresses must match with that of the Central IAP list.
- 5. Candidates, Proposers & Seconders of the Nominations filed should submit their details in the prescribed form sent to all IAPPICC members/downloadable from IAPPICC website.
- 6. A member can be nominated for more than one post (e.g. Chairperson as well as for EB member), but will have to withdraw in writing from all other posts, except one post, before the last date of withdrawal, failing which, all nominations for all posts filed by that member will stand cancelled.
- 7. In the event of an error in a Nomination Form submitted, more than one Nomination Form may be filed for the same member for the same post before the last date for submission. However, if multiple forms are sent for the same post, any one correct form will be accepted.
- 8. The nomination papers will be scrutinized by the IAP PICC Returning Officer or his/her appointed nominees for its validity. After scrutiny the Returning Officer shall send the list of valid Candidates to IAP PICC for posting on the IAP PICC website. Each eligible Candidate will also be intimated by email.

Reasons for rejection can be requested by the Candidate only by sending an Email to the member of Election Commission. Any Candidate whose nomination has been accepted can withdraw his nomination on or before the specified date of withdrawal. The decision of the Election Commissioner will be final.

- 9. IAP PICC Chapter Members whose names appear on the PICC list as of 30-Sep-2023, are eligible to participate in the Election Process. Office will not be liable for Non receipt or delay in receipt of ballot papers.
- 10. All Nominations papers of Candidates must be sent to the Election Commissioner's Office only by email to piccelection2024@gmail.com. Nominations sent elsewhere will be invalid
- 11. The correspondence from Members related to IAP PICC Election should have Full Name, address, IAP membership number, email ID & cell phone number.

Eligibility criteria for the candidates of IAP PICC Executive Board

A Candidate contesting for the post of Chairperson should have served as an office bearer of the Chapter for at least one complete term and should have been member of the chapter for at least ten years.

A Candidate contesting for the post of Vice Chairperson should have served as an office bearer of the Chapter for at least one complete term and should have been member of the chapter for at least seven years.

A Candidate contesting for the post of Executive Board Member should have been a member of the IAP PICC Chapter for a minimum Five complete years.

A candidate contesting for the post of Vice Chancellor of the Academic Council of the Intensive Care Chapter should have been a teacher in a College accredited centre for at least seven years and for the post of Executive board experience of at least five years in a College accredited centre.

Out of the 8 positions of the EB of Academic Council of Intensive Care Chapter, 4 positions are open to election from the teacher pool and they will serve for Two years.
